



Terms and Conditions

License for the Online Access to NISC Subscription Journals

1. Definitions

- Authorised User:** Member of the permanent, temporary or contract staff, *bona fide* visitors or registered students of the Licensee who are permitted access to the Secure Network via a username and password or similar system of individual authorisation.
- Licensed Materials:** The electronic materials provided by the Publisher or the Publisher's representative.
- Secure Network:** A stand-alone or virtual network which is only accessible to Authorised Users approved by the Licensee whose identity is authenticated at the time of log-in and periodically thereafter.
- Single Site:** A single contiguous geographic region from which the Licensee provides access to the Licensed Materials over a Secure Network.
- Subscription Period:** That period nominally covered by the volumes and issues of the Licensed Materials, regardless of the actual date of publication.

2. Agreement

- 2.1 Upon payment of the agreed subscription fee, the Licensee has the non-exclusive, non-transferable right to give Authorised Users access to the Licensed Materials via a Secure Network for the purposes of research, teaching and private study at a Single Site.
- 2.2 The License shall commence at the beginning of the Subscription Period and shall terminate at the end of the Subscription Period.
- 2.3 If the Licensee intends to provide access to the Licensed Materials outside of a Single Site, such as to users at a satellite campus or department at separate locality, the Licensee should contact NISC (Pty) Ltd for a multi-site license.

3. Usage rights

3.1 Authorised users may, subject to copyright law of South Africa, search, view, retrieve and display the Licensed Materials, and save and/or print individual articles or parts of articles for personal use.

3.2 Neither the Licensee nor any Authorised Users may incorporate any part of the Licensed Materials into Course Packs or e-Repositories (digital archives or electronic reserve) without the prior written permission of the Publisher.

3.3 Neither the Licensee nor any Authorised Users may make print or electronic copies systematically of multiple extracts of the Licensed Materials for any purpose.

3.4 The Publisher's explicit written permission must be obtained for use of all or part of the Licensed Materials for any other ways than those specified in Clause 3.1.

4. Supply of copies to other libraries

4.1 Neither the Licensee nor any Authorised Users may provide an electronic copy of any part of the Licensed Materials to any other Library, institution or individual user for any purpose whatsoever. However, the Licensee is permitted to supply an Authorised User of another library by post or fax a single paper copy of an individual document that is part of the Licensed Materials for the purposes of research or private study and not for any commercial use.

5. Licensee's undertakings

5.1 The Licensee shall take reasonable steps to ensure that only Authorised Users are permitted access to the Licensed Materials.

5.2 The Licensee shall take reasonable steps to notify Authorised Users of the terms and conditions of the License.

6. Termination of License

6.1 The License shall be automatically terminated, unless renewed, at the end of the Subscription Period.

6.2 If the Licensee commits a willful material and persistent breach of Publisher's copyright and intellectual property rights by deviating from or permitting a deviation of the usage rights, this License will be terminated.
